For example, social surveys were conducted in more than 800 families in different regions of the country on what should be the criteria for a modern successful family, and the model of a modern family was developed based on the final results. In particular, the declining number of divorces is a matter of serious concern. Our research in three regions of the country shows that the main reasons for the failure of families are:

Psychological factor - a difficult psychological environment in the family, lack of mutual understanding, constant conflicts in the family, parental interference in the lives of young couples, alienation of young couples, indifference to each other;

The social factors are alcoholism, infertility, and poor health of the husband or wife;

Spiritual and moral factor - a long-term extramarital affair of one of the spouses;

Economic factors are unsatisfactory housing conditions, financial hardship, unemployment, the inability of the husband to provide for his family, the loss of contact

with the family of one of the spouses who went abroad as a labor migrant, and the inability to repay debts.

It must be acknowledged that to date, more than 11,800 disputed families have not reached court, and more than 3,100 families who have filed for divorce have been reconciled with their partners. In all, 14,645 endangered families survived.

Based on the results of our research, we have developed a number of proposals aimed at preventing divorce and strengthening families. In our opinion, first of all, it is necessary to establish training of qualified personnel for the Reconciliation Commissions under the neighborhood citizens 'assemblies and the structures of the "Parents' University". It is necessary to increase the legal literacy of married citizens on the basis of the relevant legislation on the rights and obligations of the couple, in particular, the procedure, conditions and consequences of concluding a marriage contract. In this regard, it is expedient to conduct a comprehensive advocacy work, and create appropriate methodological guidelines, develop methodological recommendations. From general education schools to university curricula, it is useful to include family lessons.

Our field studies show that many of our young people, who today cross the threshold of the so-called family sanctuary, are, unfortunately, not economically, spiritually, legally, spiritually or religiously ready for an independent life. In search of a solution to this problem, we tried to improve their knowledge and skills by organizing a special training course for future brides and grooms who have applied for marriage to the Civil Registry Office in Parkent district of Tashkent region. Fifteen couples were trained in interactive, innovative methods by experts who are masters of their profession. We are popularizing this experience throughout the country, as this course, which is being continued in the Parkent district, is very popular among young people.

In addition, our specialists are implementing a new innovative approach to family issues in Namangan region. For this purpose, the complex of services provided to the family was studied in cooperation with a number of institutions in Turakurgan district. Through the organization of trainings on working with families, specialists in the field were provided with comprehensive knowledge and skills. In turn, the specialists of the Family Center are being brought closer to government and non-governmental organizations as specialists in providing family services. As a result,

disadvantaged families enjoy public services. To date, a complete scientific and practical analysis of the situation of families in the Turakurgan district has been developed, and a separate "Road Map" has been developed for each of them to free 84 of them, and these documents are being implemented.

More than 10,000 troubled families have been identified in our center, a database has been created in all our regional offices, and we are working with them individually. At the same time, practical assistance measures have been developed in collaboration with the sectors and partner organizations in the districts to address the main problems of 4,343 vulnerable families. Direct contact has been established with 3,819 families with problems in internal family relations, interpersonal relations, preservation of rich cultural and historical heritage and traditional family values. A database of more than 1.5 million sample families has been created.

Of course, working with families requires a high level of knowledge and skills, as well as unique experience. Taking this into account, special training courses on advanced training and retraining of personnel organized under the regional administrations of the center were organized, first of all, training courses were organized for the staff of the center and regional branches. At present, the training of specialists in working with women and strengthening the spiritual and moral values in families is continuing throughout the country.

In the field of the family, our center strengthens cooperation with a number of governmental and non-governmental organizations, as well as international organizations. To date, memorandums have been signed with more than 20 organizations and active cooperation has been established.

CONCLUSION

It should be noted that the concept of strengthening the institution of the family in the Republic of Uzbekistan and the implementation of the "Road Map" on its implementation was approved by the President on June 27 this year.

The main goal of the implementation of this Concept is to fully realize the rights and interests of every family in our country, to create favorable living conditions for them, to ensure the balance of family relations, to increase family well-being, in short, the institution of the family. is to achieve progress. We want every family to live a spiritually healthy, happy and peaceful life. May the children growing up in the family
