



THE INMATE CLASSIFICATION AND HOUSING CONDITIONS OF THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) OF APARRI DISTRICT JAIL: A HUMAN RIGHTS BASED APPROACH

ABSTRACT: *Republic Act 6975 otherwise known as The Local Government Code of the Philippines is the governing law that paved the way for the creation of the Bureau of Jail Management and Penology (BJMP). It was created replacing its forerunner, the Office of Jail Management and Penology of the defunct Philippine Constabulary / Integrated National Police. This study attempted to ascertain the present conditions and management of the District Jail of the Bureau of Jail Management and Penology of Aparri in the province of Cagayan specifically looking into the classification and housing services by the institution on persons deprived of liberty (PDLs) more popularly known as detainees. This study utilized the one hundred seven (107) detainees, twenty-six (26) personnel and twenty-one (21) visitors as the source of the data needed in this undertaking. The descriptive correlational method of research was used (Fraenkel and Wallen 1993). The descriptive statistics was employed to summarize the mean and the weighted mean was utilized in the analysis and interpretation of the perception of the respondents as regards the different domains. For the analysis and interpretation of the perception of the respondents as regards to the different domains, the Kruskal Wallis Test and One way Analysis of Variance (ANOVA) were used. A questionnaire was utilized to gather information from the respondents which consisted of the two domains, namely: the inmate classification domain and the housing domain. This data gathering tool was patterned from Dr. Raymund E. Narag in his study entitled “Baseline Study on the Philippine Penal Conditions in coordination with the CHR-Phils.” This study pointed out that the facilities and services specifically on the classification and housing services provided by the detention center are within the category labelled as “meeting standards” as revealed in the results of this undertaking. Thus, it is strongly recommended, by way of innovative measure and enforcement that the BJMP should device a scheme on a greater provision of the basic needs of the inmates through the inclusion of a bigger budget allocation and a mechanism for the provision on the needs of the LGBT inmates specifically on the separate housing to provide them the privacy of personal needs attendant to their sexual orientation.*

INTRODUCTION

Republic Act 6975 otherwise known as **The Local Government Code of the Philippines** is the governing law that paved the way for the creation of the Bureau of Jail Management and Penology (**BJMP**). It was created replacing its forerunner, the Office of Jail Management and Penology of the defunct Philippine Constabulary / Integrated National Police.

Republic Act 6975 empowers the Department of Interior and Local Government to exercise supervision and control over all district, city and municipal jails. As such, it shall ensure the establishment of secured, clean, adequately equipped and sanitary facilities and the provision of quality services for the custody, safekeeping and development of district, city and municipal inmates, whether awaiting or undergoing investigation or trial and/or transfer to the National Penitentiary. It also caters to the needs of mentally ill person who endangers himself or the safety of others as certified by proper medical or health officer, pending transfer to a mental institution.

Indeed, an effective penal management necessitates the Bureau of Jail Management and Penology (BJMP) to carry out its aforequoted mandate aimed at mainstreaming and adopting the multi-dimensional “ **Human Rights Based Approach (HRBA)**” as a conceptual framework to Effective Penal Management - a key component in the administration of Criminal Justice System. This study seeks to analyze the inequalities brought about by the lack of awareness on gender issues that contribute to the development problems, discriminatory practices and unjust distribution of power within the penal institution which to a larger extent impede effective management and development in the penal sector.

In the Wolf Report (2011), it was specifically pointed out the disturbances in prisons which were more wide-ranging than was probably intended and thus came up with recommendations to wit: (1). More visible leadership of the Prison Service by a Director-General who is and is seen to be the operational head and in a day-to-day charge of the Service. Toward achieving yhis goal, there should be a published ‘compact’ or ‘contract’ given by ministers to the Director-General of the Prison Service who should be responsible for its enforcement and publicly answerable for any breach thereof and at the same time, responsible for the day to day operations of the Prison Service; (2) A ‘compact’ or ‘contract’ for each prisoner setting out the prisoner’s expectations and responsibilities in the prison in which he or she is held; (3) Better prospects for prisoners to maintain their links with



families and the community thereby allowing more visits; and (4). Improved standards of justice within prisons involving: the giving of reasons to a prisoner for any decision which materially and adversely affects him.

MacDonald and Sim (2010), in terms of physical conditions and personal relationships between prisoners and the staff the unit had progressed away from the traditional authoritarian non-relationships and Spartan conditions that the majority of long-term prisoners in Scotland face. There is a great deal of freedom, responsibility and personal choice given to prisoners within the confines of the unit. The men wear their own clothes rather than prison uniform. They can decorate their own cells and keep books and record players. They can cook their own food, supplementing prison rations with food bought with their own money. Their mail, unlike that of prisoners in the traditional system, is locked up at night. Each prisoner plans his own routine for the day and democratic community-either staff or prisoner – who ‘lets the side down’ by breaking the rules, can end up in the ‘hot seat’ where his actions are discussed, criticized and chastised by the other members of the community, again whether staff or prisoner

Adams and Adams (2010) relate their experiences of the penal system. She described the difficulties involved in visiting a prisoner as follows. That no directions were given as to how to get to the prison, so she ended up having to face the embarrassment of asking on a bus as to its whereabouts. Upon arrival she found that you had to wait outside the prison, a situation also being faced by a mother with an infant who had a cold. In the winter the transport situation was that if a taxi was not taken and paid for then there was a risk that the visit would be missed.

Smith (2012) provides an interesting critique of the concept of ‘healthy prisons’, with some significant references to its implications for women in prison. She highlights the dangers of initially laudable health promoting initiatives turning into ‘surveillance medicine’ or ‘health policing’ with women being held responsible (but without power) for their own health in an environment which is intrinsically ‘disadvantageous ... for good health’. An example is the increasing trend to ban smoking in the visits areas of prisons. Of it, this is a laudable policy, since smoke-field visiting halls are undoubtedly very unpleasant and unhealthy environments. Nevertheless, they are also extremely stressful places for prisoners and visitors alike and smoking prohibitions add to that stress for many. There can be no right



answer because the situation is inherently 'unhealthy' in the first place. A further example is the promotion of 'healthy eating' among women in prison. Women are exhorted to eat healthy yet the quality of prison food and the limited availability of salads and fresh fruit make this very difficult. Women in prison have little control over the food that is available to them in closed prisons often have to eat it in their cells, on their beds and next to their toilets:

The food is far too stodgy, and if, on top of that, they're not getting any physical activity many of them are concerned about their weight. It's all self-image. If you're feeling particularly low, often one of the things you try to do is to maintain your own physical appearance as a way of combating the low self-esteem that you feel... Women would be more than happy with salads and sandwiches, rather than having three cooked meals in a day [but] three cooked meals is what they get.

Bonta (2011) has identified four key principles necessary for correctional programming to be effective: (1) Risk: programmes intensity should be matched to the risk of re-offending. Those at greater risk require more intensive programmes, while programmes delivered to those least at risk may actually increase recidivism. Therefore it is essential that reliable risk assessments are undertaken; (2) Need: programmes should focus upon those characteristics which are statistically associated with recidivism and relatively stable but nevertheless changeable. These predictors of future criminal conduct are called criminogenic needs or dynamic risk factors. Most are linked to deficit or faulty thinking such as pro-criminal attitudes, interpersonal problem-solving, impulsivity, rigid thinking, a tendency to blame others and an external locus of control. Others include substance use and criminal associates. Static risk factors are unchangeable characteristics statistically associated with re-offending and include gender, age, criminal history and early family factors such as little or no affection, supervision or discipline from parents. Non-criminogenic factors are said to include social class, personal distress variables (such as self-esteem, anxiety and depression), and feelings of alienation, psychological discomfort and group cohesion. The need principle therefore recommends that only programmes which address criminogenic needs/dynamic risks should be offered to offenders; (3) Responsivity: the delivery approach should match the learning styles of offenders. It is claimed that offenders are most responsive to cognitive behavioral programmes which employ a skills-oriented approach to



delivery; (4) Integrity: treatment should be conducted in a structured way with strict adherence to the programmes manual, and delivered by enthusiastic and dedicated staff according to the principles outlined above.

As mentioned in the study of Tejaro (2015), the different programs introduced by the government for the rehabilitation of offenders need a lot of resources for its proper implementation. Trained jail officers to implement the programs would mean more personnel for them to focus of the different programs. The continuity of its implementation would also require a lot of funds allotted for its proper and timely implementation. With these, a better result is expected and this would help the offenders adjust with the changes in their lives inside the jail and in preparation for their reintegration.

STATEMENT OF THE PROBLEM

This study attempted to ascertain the present conditions and management of the District Jail of the Bureau of Jail Management and Penology of Aparri in the province of Cagayan. Specifically, it attempted to answer the following questions:

1. What is the perception of the respondents on the current condition of the inmates in terms of the following domains:
 - a. classification domain
 - b. housing domain
2. Is there a significant difference on the current condition of the inmates as perceived by the respondents when grouped according to the different domains?

HYPOTHESIS

This study was guided by the lone hypothesis, that there is no significant difference on the current condition of the inmates as perceived by the inmate-respondents, personnel-respondents and visitors-respondents when grouped according to the different domains.

RESPONDENTS OF THE STUDY

The study utilized the detainees, personnel and visitors of the District Jail.

METHODOLOGY

Since this study has attempted to ascertain the management of the District Jail of the Bureau of Jail Management and Penology of Aparri in the province of Cagayan, the descriptive correlational method of research was used (Fraenkel and Wallen 1993). The descriptive statistics was employed to summarize the mean and in the analysis and interpretation of the perception of the respondents as regards the different domains, the weighted mean was utilized. For the analysis and interpretation of the perception of the respondents as regards the different domains, the Kruskal Wallis Test and One way Analysis of Variance (ANOVA) were used. A questionnaire was utilized to gather information from the respondents which consisted of the two domains, namely: the inmate classification domain, the housing domain. This data gathering tool was patterned from Dr. Raymund E. Narag (**Baseline Study on the Philippine Penal Conditions in coordination with the CHR-Phils**)

STATISTICAL TOOLS

In the analysis and interpretation of the perception of the respondents as regards the different domains, the weighted mean were used which is calculated by the equation:

The weighted mean was interpreted using the following criterion scale:

To test any significant difference in the perception of the respondents as to the current condition of the inmates when grouped according the different domains, the Kruskal Wallis and ANOVAs were utilized.

RESULTS AND DISCUSSIONS

Table 1.1.a shows the item mean on the perception of the detainee-respondents as to the inmate classification domain. As revealed in the results, except for the item on “***The facility has resources allotted for purposes of classification***” rated as **partially complied**, the detainee-respondents rated all the items in this category as **fully complied** with a category mean of 2.70. This implies



that the detainee-respondents are fully satisfied with the facilities existing in the district jail, though improvements may still be initiated for the comfort of the detainees.

Table 1.1.b shows the item mean on the perception of the personnel-respondents as to the inmate classification domain. As revealed in the results, except for the item on “*the facility has a well-maintained classification cell with individual bed bunks*” rated as **partially complied**, the personnel-respondents rated all the items in this category as **fully complied** with a category mean of 2.72. This implies that the personnel-respondents are fully satisfied with the facilities existing in the detention center, though improvements may still be initiated for the comfort of the detainees.

Table 2.1.d presents the summary of the perceptions of the respondents as to inmate housing domain. As gleaned from the table, all the respondents unanimously rated this category as “**fully complied**” with the numerical values of 2.53 for the detainee-respondents, 2.55 for the personnel-respondents and 2.66 for the visitor-respondents. This implies that all of the respondents are **fully satisfied** with the provision on inmate housing domain, though some items need to be given attention to for the comfort and convenience of the detainees.

Table 3 shows the significant difference on the respondents' perception as to inmate classification domain. As revealed in the table, the test employed the chi-square relationship whose values are 9.502 and the the computed p-value is .009 at 0.05 level of significance. Since, the computed p-value is very much lesser at 0.05 level of significance, hence; the null hypothesis is rejected. Thus, a significant difference in the perceptions of the respondents exists as to inmate classification domain. Also, using the mean comparison test, the mean perception of detainee-respondents (mean=2.70) is significantly lower than the mean perception of visitor-respondents (mean=2.90).

Table 4 shows the significant difference on the respondents' perception as to housing classification domain. As revealed in the table, the test employed the chi-square relationship whose values are 5.183 and the computed p-value is .075 at 0.05 level of significance. Since, the computed p-value is very much greater at 0.05 level of significance, hence; the null hypothesis is accepted. Thus, no significant difference on the perception of the respondents exists as to housing classification domain.

CONCLUSIONS AND RECOMMENDATIONS

The Bureau of Jail Management and Penology as an integral part of the Department of Interior and Local Government is expected to deliver quality services to their clientele. To realize this, a healthy or a pleasant or even excellent programs and facilities must be ensured to provide the detainees the comfort and means of reformation in preparation for



their reintegration in the society. This study pointed out that the facilities and services specifically the classification, housing, and programming and on the documentation and assessment services provided by the detention center are “meeting standards” as revealed in the results of this undertaking.

In the light of the findings arrived at, it is strongly recommended that the agency must include as one of its programs the following:

1. A mechanism for the provision on the needs of the LGBT inmates specifically on the separate housing to provide them the privacy of personal needs attendant to their sexual orientation.
2. The management should device a scheme on a greater provision of the basic needs of the inmates through the inclusion of a bigger allocation of the same.
3. The establishment of a facility that would separate the detention prisoners from the convicted prisoners.
4. Additional bed bunks should be provided by the management to the inmates for their convenience.
5. A development plan should be provided for feed backing and suggestions from inmates and visitors must be properly treated and recognized by the management.
